Message from the President Deidre Kelley



The 81th Anniversary of the Japanese bombing of Pearl Harbor was celebrated by more than 60 members of SDPHS, their families and guests at the 2022 National Convention in Savannah, GA. Members toured the beautiful City of Savannah, enjoyed the Christmas show at the historic Savannah Theater, and toured the National Museum of the Mighty Eighth Air Force. Child survivor and Texas State Chair, Ann McKennis, shared a presentation about the "Nurses of Pearl Harbor" and our banquet speaker, Colonel Christopher Noe talked about vigilance and how Pearl Harbor and the events of December 7, 1941 relate to it. He also shared his own experiences in Iraq, Afghanistan, Korea, and Germany. Colonel Noe is the grandson of Pearl Harbor Survivor Charles J. Haessig who was stationed on the USS Sacramento on December 7, 1941. Banquet entertainment was provided by Kristin King, New Arts Ensembles, solo harpist.

The General Membership meeting was well attended and many ideas for generating donations to our organization were discussed. 



Sons & Daughters of Pearl Harbor Survivors Honor their Fathers

The 81st Anniversary of the attack on Pearl Harbor was celebrated in Springfield on December 7th. On December 7th, 1941, Pearl Harbor, on the Island of Oahu, Hawaii, was attacked by the Japanese Imperial Navy. The surprise attack was comprised of 353 Japanese aircraft. The assault, which lasted less than two hours, claimed the lives of more than 2,403 people, wounded 1,000 more and damaged or destroyed 18 American ships and more than 300 airplanes. Eighty-one years later, we gathered to reflect on the day that will forever be remembered as "a date which will live in infamy" and to honor the memory and courage of those that served on that fateful day.

This remembrance ceremony was co-hosted by the Illinois Department of Veterans' Affairs (IDVA) and the Springfield Elks Lodge #158. Gwen Diehl, IDVA, was the moderator and the following offered remarks: James Langfelder, Mayor of Springfield; Terry Prince, Director, Illinois Department of Veterans' Affairs; John Carrigan, VP, World War II Memorial Committee; and Bobby Edwards, Department of Illinois VFW District 10 Commander. Governor Pritzker sent a proclamation naming December 7th as Pearl Harbor Remembrance day in Illinois.

The indoor ceremony was followed by casting memorial wreaths into Lake Springfield, a three volley salute, and bagpipes playing Amazing Grace.

Jim Tripplet (SDPHS) and Terry Prince, Director of Illinois Department of Veterans' Affairs threw wreaths in memory of those who paid the ultimate sacrifice on December 7, 1941.


Nebraska Chapter

Arizona Chapter

Arizona Chapter 1 was chartered in November 2011 in Prescott, AZ with just the bare minimum number of active members. Although there are 89 dues paying SDPHS members in Arizona, only 18 of those in or near Prescott have ever attended our regular meetings held monthly up until Covid 19 put an end to them. During the Covid years, four of our most active members passed away. Now, with only 8 or 9 truly "active" members, the chapter is not sustainable.

Chapter 1 President Bill Williamson with several officers and Prescott members held a planning meeting in March 2022 to decide if we should continue to hold meetings and, if so, how to proceed. It was suggested that instead of monthly meetings, we should try quarterly meetings. Because Covid is still with us, and most of us are vulnerable seniors, it was also suggested that we try virtual meetings on Zoom. This would allow us to once again hold meetings and would expand our reach to include all Arizona SDPHS members. The core group is determined to carry on!

Our chapter has purchased a one year ZOOM contract, allowing us to have unlimited time for our meetings, as was proposed and approved at our first Zoom meeting held on October 15th. That meeting had eight attendees.

An email notice was sent to all members with a listed email address before Thanksgiving and again on December 1st to notify all Arizona members of the upcoming quarterly meeting on December 7th. The notice listed the topics to be covered during the Zoom meeting.

On December 7, 2022 at 7 pm AZ State Chair Bill Williamson opened the second statewide Zoom meeting for all Arizona SDPHS members. We were disappointed to have only six members attend, because there are fifty-eight names on the latest member list sent to us by National.

One major question is how many dues paid members do we really have in AZ and how can we contact them. It was proposed that we divide up the list from National and each member present at the December 7th meeting will try to contact 10 members personally by whatever contact information we have to find out if they are still members, whether they are still interested in the organization, how can we best contact them, and if they have the capability to attend ZOOM meetings on a computer. The results from this effort will determine how to best proceed.

We also learned at the meeting that not everyone received a dues reminder and not everyone is receiving the "Offspring", so we will send an email copy of the dues reminder and the latest copy of the "Offspring" to every member on our email list.

Survivor's Stories

Captain Edwin John Kroeger

Captain Edwin John Kroeger (USN)

Captain Edwin John Kroeger (aka Bud) earned his Navy wings from NAS Pensacola flight school August 5th, 1938. The newly minted Ensign JG was assigned to the recently commissioned carrier USS Enterprise, serving with Bombing Squadron Six (VB-6) and piloting the venerable Douglas "Dauntless" SBD dive bomber. The Enterprise, initially assigned to the Pacific Fleet off Coronado Island in San Diego, was later reassigned to Pearl Harbor, Hawaii in September of 1939.

On December 4, 1941, Enterprise was ordered to deliver a Marine F4F Wildcat Squadron to Wake Island with a scheduled return to Pearl on December 6th, but was fortuitously delayed by stormy seas. Due to increasingly strained relations with Japan, U.S Fleet Task Force Commander Admiral William (Bull) Halsey had prudently ordered the fleet to operate under wartime conditions which dictated flying scouting missions ahead of the advancing carrier while under radio silence. Upon approaching Pearl on December 7th-still 200 miles out and unaware of the ensuing enemy attack- Halsey ordered an 18 sector area search with two planes assigned to each sector. Bud's sector was to take him in the vicinity of Waikiki Beach, with a second leg over Barbers Point, and upon completion, to land on Ford Island.

Radio silence was ultimately broken by frantic chatter alerting everyone listening that Pearl was under heavy enemy attack, exclaiming- "This Is Not a Drill!" The "Big E" scout planes soon encountered dense smoke and flames from burning vessels in the harbor plus massive ground devastation. As Ford Island was an inferno, Bud and his wingman, Dale Hilton, made the prudent decision to re-route and attempt a landing at Ewa Field. During their approach, they were mistakenly identified as enemy planes by bewildered and overwhelmed U.S personnel necessitating the pilots to evade friendly fire emanating from multiple sources; the critically wounded Nevada as she attempted to beach herself, destroyers frantically attempting to escape from the harbor, and ground personnel. Fortunately, neither Bud's nor Dale's plane was seriously hit which allowed both pilots to land, arm, refuel and launch with other SBD pilots in pursuit of the enemy-which by this time had made a hasty retreat.

In February of 1942, Bud took part in one of the first "payback" hit and run raids on Japanese possessions in the Pacific with strikes on Kwajalein and Tarawa in the Marshall Islands. Dodging intense antiaircraft fire, he was then attacked by three enemy fighter planes necessitating evasive maneuvers in an attempt to escape. One of the Jap fighters strafed his plane from below with machinegun fire riddling his SBD with bullet holes and sending an exploding round through his left foot. Bleeding profusely and without the ability to fully control his rudder, Bud miraculously managed to fly his severely damaged plane back to Enterprise and safely land, even after first circling the carrier selflessly allowing all the other pilots to touch down. His aircraft was so shot up, the decision was made to scrap it, and consequently, it was pushed overboard.

Bud was transferred to the hospital ship Solace to convalesce from his wound where doctors thankfully saved his leg from amputation. He would make an eventual return to the Big E just in time for the engagement that became "The Turning Point of the Pacific conflict- the Battle of Midway!"





On June 4th, 1942, a trio of Enterprise SBD's comprised of: Dick Best in command, Bud as his wingman, and Fred Weber, spun off of a larger formation of dive bombers to spearhead an attack on the Japanese flagship carrier Akagi. While all three pilot's bomb strikes were credited with damaging the enemy ship, Bud's 1000 pound bomb inflicted the most catastrophic carnage-piercing the carrier deck near the amidships elevator, thus, dooming it After returning to the Enterprise to refuel and rearm, he and the few surviving SBD pilots from carriers Enterprise an Yorktown rallied for another run at the now critically damaged Japanese fleet, successfully sinking the two remaining carriers-Hirvu and Soryu- thereby culminating one of the most decisive battles in Naval history.

At the conclusion of Midway, Bud had completed his scheduled 4 year tour with Enterprise and received orders returning him to Pensacola to assist with new pilot training. In 1944, he was recalled into combat as VB-7 Squadron Executive Officer aboard the newly commissioned USS Hancock. He led several sorties during the battle of Leyte Gulf, and in November of '44 was assigned to the USS Homet to finalize his wartime service as Commander of Air Group II (VB-11). Throughout November '44-January '45, he flew the Curtis SB2C Helldiver in combat missions striking Japanese positions in the Philippines, Formosa, Cam Ranh Bay, Hong Kong and Okinawa, ultimately racking up a combined total of 65 combat missions.

After the war in 1947, Bud served aboard the USS Boxer as CO of VB-19 flying the newly released Douglas Skyraider- a plane he truly loved!

In 1952, he was given command of Air Group 6 aboard the USS Midway where he was honored by completing the historic 50,000th carrier landing.

In 1958, Bud reluctantly traded in his wings for diplomatic duty, assuming the post of Attaché under Dwight Eisenhower at Columbia University and later as Naval Attaché at the American Embassy in Belgrade, Yugoslavia.

As his final assignment, he headed the Department of Naval Intelligence in Boston, MA, supervising the investigation of numerous high profile national cases. In 1962, with the rank of Captain, Bud retired from his exemplary Naval career.

During his wartime combat service, Captain Edwin John (Bud) Kroeger was awarded the following:

*The Navy Cross

*3 Distinguished Flying Crosses

*3 Air Medals

*Bronze Star

*Purple Heart

*Numerous campaign citations and commendations Bud earned his eternal wings on September 29, 2002 one month shy of his 89th birthday.

Survivor's Stories

This information was told to me by my father.

My father John Herwer joined the US Navy on Oct 1939, this was after he had spent two years in the US Army reserve in 1937 where he made the rank of corporal E-4. The Navy sent dad to basic training at San Diego Naval Training Center. After basic he was assigned to the USS Tern AM-31 a mine sweeper. At that time the pacific fleet was stationed at San Diego, CA During the summer of 1940 the pacific fleet was then moved to Pearl Harbor, TH.

On Dec 7th 1941 the USS Tern was moored at the end of 1010 dock, (so called because the dock was one thousand ten feet long). At 0700 my dad left the Tern headed for the USS Helena, He had to cross over the Helena to get to the USS Oglaga where he was to meet his buddy, they were going to Pearl City that morning. As my dad stepped on the gang plank of the Helena, he heard machine gun fire from the torpedo bombers, they launched their first torpedo at the USS Arizona. Seconds later he saw the USS Shaw go up in smoke and fire. With all the smoke and fires going on the Helena would not let my dad on

About this time a Navy truck was passing by and they shouted at him to get on board, there was a 50 caliber machine gun on board which they set up on a ball field. Later the Marines took over the 50 caliber and he was sent back to his ship.

The Tern was assigned to put out fires on the USS Arizona and later moved over to the USS West Virginia to put out fires. The Tern pulled out forty sailors from the burning water. My dad was a former life guard at the Redondo Beach salt water plug, he saw where some of the sailors were not going to make it out of the burning water. He dove into the water and pulled them out and aboard the Tern.

In March 1942 my dad, a Gunner's mate 2c, was transferred to the USS Preble, In May, 1942 he was transferred to the USS Medusa. In Nov 1942 he was transferred to Mine assembly unit 134 Brisbane, Australia . He helped set up a mine production unit. where he stayed until the end of the war. In Oct 1945 my dad was assigned to mineman "A" school in Yorktown, Virginia that is a distance of over 15,000 miles. In 1959 my dad a Chief Mineman retired with 22 years of military service
